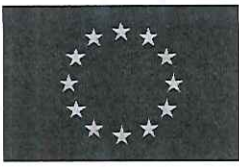
The clarification meeting started at 11.00 h.


All participants at the Clarification Meeting received Certificates of attendance and signed the List of presence.
